## WHAT IS QUEST?

Quest is a record keeping system that helps you keep track of your operating rules testing and qualifications for your operating personnel.

## WHAT TYPES OF TESTS CAN QUEST KEEP TRACK OF?

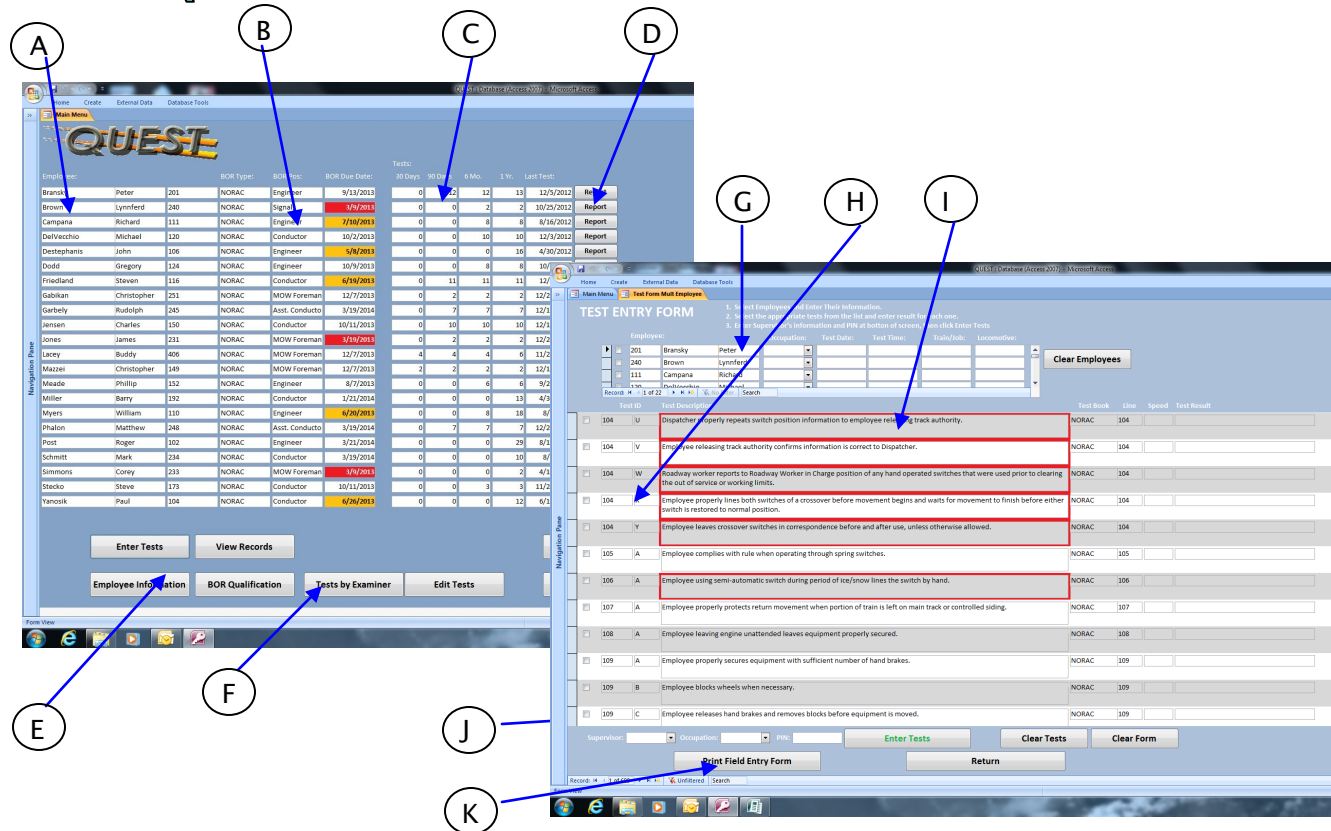
Literally, any type of testing that you want. The tests can be entered and organized by just about any way imaginable. In addition, it is possible to highlight rules that you want to have your examiners focus on. Book of Rules type qualifications can be customized for the requalification period.

## HOW DOES QUEST KEEP YOU INFORMED?

Quest will show you on one screen the employee, what their rules qualification is, when it expires, and how many operating rules tests have been performed on them in the last 30, 90, 180 and 365 days. In addition, the system will show you who has performed the tests, and how many tests that person has performed over the same periods.

## WHAT TYPE OF EQUIPMENT DOES QUEST REQUIRE?

Quest will run on any Windows PC with MS Access 2007 or newer installed. Quest can also be installed on a network.



A - Employee name and ID Number. All employees entered are listed.

B - Book of Rules type, position qualified for, and requalification date are shown.

C - Number of operational performance tests performed on that employee over the last 30, 90, 180, and 365 days.

D - A full testing history of each employee is available.

E - Test entry and reports are available with one click.

F - Records of how many tests your examiners have performed are available.

G - Employees and their information are recorded here

H - Tests are organized per the user's specifications

I - Test description, and if a test is to receive focus it is highlighted.

J - Examiners enter their information in this area, and all entries by an examiner require a PIN.

K - A field entry form can be printed out for use away from a computer, or the system can be installed on a laptop for field use.
